- Mức lương tối thiểu vùng được điều chỉnh tăng theo quy định của Chính phủ tăng 6% từ 01/7/2024 theo Nghị định số 74/2024/NĐ-CP ngày 30/06/2024 và từ 01/01/2026 mức lương tối thiểu vùng tiếp tục tăng 7.1% theo Nghị định số 293/2025/NĐ-CP ngày 10/11/2025;

*Adjustment of Regional Minimum Wage: The minimum wage was adjusted upward by the Government, increasing by 6% effective from July 1<sup>st</sup>, 2024, under Decree No. 74/2024/ND-CP dated June 30<sup>th</sup>, 2024 and from January 01<sup>st</sup>, 2026, the regional minimum wage will continue to increase by 7.1% in accordance with Decree No. 293/2025/ND-CP dated 10 November 2025 .*

*Rising Cost of Living: A notable increase in the Consumer Price Index (CPI) and general living expenses.*

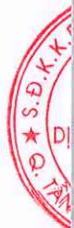
